## RE: Ski Trip 2022, Reserve Lists Students who are able to travel

Further to my recent correspondence, I have now had a meeting with Dr Bevan in order to discuss the latest guidance we have received from SkiTeam4 in regards to our Ski Trip in February 2022.

SkiTeam4 have advised us that in order for students to access hotels, ski lifts and restaurants in Italy; they will need to have a 'super green pass'. This is only available to those over 12 years of age who are double vaccinated (14 days prior to travel).

As a result of this, I am now able to offer your son/daughter a place on this trip. Our records indicate that your son/daughter is able to attend this trip on merit of either:

- A. Already being double vaccinated
- B. Having the opportunity (based on the date of the first vaccination) to be double jabbed by 28th January 2022
- C. Is under 12 years of age, and thus exempt from vaccination requirements

Please can you complete the <u>both</u> MS Forms below to confirm that your son/daughter does wish to attend the Ski Trip and that they meet the required criteria. I request that this form be completed by no later than **3.30pm tomorrow**, **Thursday 20**<sup>th</sup> **January**. Apologies for the limited notice of this requirement and the urgency of completion; you will appreciate we are under considerable pressure to confirm final numbers as soon as possible.

The total cost of this trip is £985.00, as departure is imminent, we will require the full amount to be paid by **3.30pm on Wednesday 26**<sup>th</sup> **January.**
