NOTES:

If your appeal is unsuccessful you may not appeal for the same school within the same academic year unless there has been a significant and material change in either your circumstances or the circumstances of the school and your application has still been refused. The acceptance of a place at an alternative school does not affect your right of appeal.

Complaints about the appeal

If, after the appeal, you are concerned the administration of the appeal did not comply with the Appeals Code and this affected the outcome of the appeal, you can complain about maladministration to the Secretary of State.

If the DfE finds the appeal arrangements did not comply with the Appeals Code, the academy may be required to establish a fresh appeal panel to hear the case. However, the Secretary of State cannot overturn the decision of an independent appeal panel. This may only be challenged through the Courts through a Judicial Review. Complainants should take their own legal advice in relation to this.
